AMATEUR ATHLETE WAIVER AND RELEASE OF LIABILITY

1. I agree that prior to such participation, I will, or, if I am the parent or guardian of a minor participant that he or she should, inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will immediately advise a supervisor of such condition(s) and refuse to participate.
2. I acknowledge and fully understand that I may be engaging in activities that involve inherent risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence but the actions, inactions or negligence of others, the rules of play, or the conditions of the premises or of any equipment used. Further, that there may be other risks not known to me or not reasonably foreseeable at this time.
3. I assume all the foregoing risks and accept personal responsibility for my personal damages following my injury, permanent disability or death.
4. Intending to be legally bound, I do hereby release, waive, forever discharge and covenant not to sue the State of Wisconsin, the City of Madison, The Greater Madison Convention and Visitors Bureau (GMCVB), Wisconsin Sports Development Corporation (WSDC), World Triathlon Corporation (WTC), hosts of Fun Run, its affiliated clubs, administrators, officers, directors, agents and other employees and volunteers of the organization, other participants, event organizers, event promoters, all state, city, town, county, and other governmental bodies, and/or municipal agencies whose property and/or personnel are used and/or in anyway assist in locations in which the event or segments of the event take place, and each of their respective parent, subsidiary and affiliated companies, licensees, officers, directors, partners, board members, shareholders, members, supervisors, insurers, agents, employees, volunteers, sponsoring agencies, sponsors, advertisers, vendors, and, if applicable, owners/lessors of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from any and all liability to me, my heirs and next of kin for any claims, demands, liabilities of every kind, losses or damages (including direct, indirect, incidental, special, and/or consequential), losses (economic and non-economic) on account of injury, including death or damages to property, caused or alleged to be caused in whole or in part by the negligence of any release or otherwise in connection with association or participation in and/or arising out of my travel to, participation in and returning from participation in the Fun Run.
5. I hereby consent to allow my picture and/or voice or likeness to appear in any official documentary, promotional, exclusive television, radio or film coverage, commercial advertisement of the GMCVB in any manner incidental to my participation in the Fun Run or related activities and without compensation to me.
6. I acknowledge and agree that the GMCVB, in its sole discretion, may delay or cancel the Event if it believes the conditions on the race day are unsafe. In the event the Event is delayed or cancelled for any reason, including but not limited to acts of God or the elements (including without limitation, wind, rain, hail, hurricane, tornado, earthquake), acts of terrorism, fire, threatened or actual strike, labor difficulty, work stoppage, insurrection, war, public disaster, flood, unavoidable casualty, race course conditions, or any other cause beyond the control of GMCVB.
7. I understand that GMCVB reserves the right, in its sole and complete discretion, to deny entry, revoke the entry application of any applicant at any time, and/or to disqualify any participant from the Event. I expressly waive any claim for damages arising from the denial or revocation of an entry application exceeding the amount of the entry fee.
8. I understand, agree and consent on behalf of the Minor that any dispute or claim arising out of, relating to or in connection with this Agreement or participation in this Event, including but not limited to all questions regarding issues of fault, liability, negligence, contributory negligence, damages, jurisdiction, the existence, scope, validity, performance, interpretation, termination, as well as entitlement to and amount of attorneys' fees and costs to the prevailing party, shall be determined by binding arbitration as the sole remedy as to all matters in dispute.
